## ***4. Mental Stillness App***

Over the last month we have had Mental Health Week and this was brought to my attention. Anxiety is a major issue for many people of all ages and al-

though the Mental Stillness App was designed with school-aged young people in mind, it should be noted that it is also suitable for use by adults.

At this time of the year young people around Australia experience extraordinary levels of stress. Stress not only effects mental and physical health but can itself impact on exam performance. To help our young people deal with this issue Generation Next and Sydney University's Department of Psychiatry have developed this free, evidence based, easy to use app.

Designed specifically for young people, it quickly and effortlessly upskills young people with a simple, evidence based mindfulness/meditation method that reduces stress and improves mental wellbeing.

The specific techniques and video sequences used in the app have been the subject of several clinical trials and field studies conducted in Australian state schools and hospitals under the auspices of the University of Sydney and the University of NSW, all of which have demonstrated specific effectiveness. ### ***6. Women's Earth and Climate Action Network (WECAN)***

This November 6 through 17, 2017, the Women's Earth and Climate Action Network will take action and advocate on the ground in Bonn, Germany during the United Nations Framework Convention on Climate Change (UNFCCC) COP23 Climate Talks.

Since the organization's founding, WECAN International has been participating in the UNFCCC climate process as a voice for climate justice, gender equality, Indigenous rights, Rights of Nature and meaningful, bold action on climate change.

As a central facet of WECAN's yearly work at the UNFCCC, we are honoured to support and collaborate with many frontline, grassroots and Indigenous women leaders in creating opportunities for them to speak out and present their vital struggles, stories and calls to action during the COP - thus engaging with the policy makers whose actions and inaction on climate change impacts their lives, communities and homelands on a daily basis.

As we look to the 2017 COP23 in Bonn, WECAN International reaffirms our commitment to ceaseless effort to bring women's voices to the forefront - and unyielding action to expose the roots of climate chaos and help usher in just climate solutions commensurate to the level of crisis we face. As an organization with an international focus and network, but a United States base location, we will also continue to stand with many U.S. allies to send an urgent message to the world that, even in the face of a climate-denying and reckless U.S. administration, many people across the country can, and will, stand up for climate justice, sustainability solutions, and systemic change.

**Audrey Fagan Grant Program:** Two of our members, Ellen Scott and Caitlyn Williams, have recently successfully secured \$1,200 from the Audrey Fagan Grant Program to run their idea called SisterACT. As NCW ACT young women's subcommittee members the subcommittee will be supporting and mentoring Ellen and Caitlyn through the process. The aims of the project as outlined in the application are as follows:

*The aim of the project is to set up an online forum for young people, consisting primarily of high-school age girls in the first instance, to ask questions and discuss issues that they find important. To enable this we propose a pilot program for up to 30 high school girls aged 14-18 from three schools to participate in external workshops to learn skills in leadership, advocacy and communication. The workshops will establish a foundation for the girls to network and to discuss the issues that impact them by creating groups within each school and by staying connected through the online forum.*

*The online forum will be a safe, anonymous space moderated by the administrators where people can share their ideas about particular issues, articles or books. The workshops would be designed to build the skills of the admins in crafting social media content and advocate for important issues. These skills would translate to the online forum and create a positive feedback loop for other girls in the community, allowing them to ask questions that they wouldn't be able to within a traditional school environment for example respectful relationships.*

These aims and ideas will be developed further to ensure risks are mitigated and the girls participating are getting maximum benefit from the program.

Beryl Evans was a Life Member of NCWA. She was part of the NCW(A) for many years. As she was the Dieticians Association representative to the council she and Wendy Gray became voluntary Nutrition Advisors to the NCW of Australia. These two initiated a number of high profile Nutrition Education Projects on behalf of the NCW. In 1986: the 'International Year of Peace' the NCW (A) applied for a small grant to print a 'Recipes for Peace' book. Whilst the project was a challenge, the book is still here today after several reprints

including in the USA for the 'International Year of Peace and Culture'.

Beryl was characterised by her many ideas, her enthusiasm and most importantly her wisdom. Her enthusiasm for her Family, nutrition education, world peace for justice and equality for women and their families was legendary. She will be missed by her friends and by NCWA.
